INFORMATION REQUEST APPLICATION FORM UNDER THE LAW NO. 6698 ON THE PROTECTION OF PERSONAL DATA

1. GENERAL EXPLANATIONS

As Akasya Çocuk Dünyası A.Ş. (“KidZania Istanbul” or the “Company”), the protection of privacy, particularly the protection of fundamental rights and freedoms, ensuring information security, and respect for ethical values are among our primary principles. Article 11 of the Law No. 6698 on the Protection of Personal Data (“KVKK”), titled “Rights of the Data Subject,” grants data subjects certain rights to submit requests regarding the processing of their personal data. As the Data Controller, our Company has prepared this information request application form to enable Data Subjects to exercise these rights and to fulfill the obligation to inform set forth under Article 10 of the KVKK.

Pursuant to Article 11 of the KVKK, you may exercise the following rights by applying to our Company and completing the attached form:

- a) To learn whether your personal data is being processed,
- b) To request information if your personal data has been processed,
- c) To learn the purpose of processing your personal data and whether such data is used in accordance with its purpose,
- d) To learn the third parties to whom your personal data has been transferred, whether domestically or abroad,
- e) To request correction if your personal data has been processed incompletely or inaccurately,
- f) To request the deletion or destruction of personal data within the framework of the conditions stipulated under Article 7 of the KVKK,
- g) To request that the transactions carried out pursuant to subparagraphs (e) and (f) be notified to third parties to whom the personal data has been transferred,
- h) To object to the occurrence of a result against you by means of analysis of the processed data exclusively through automated systems,
- i) To request compensation for damages if you suffer damage due to the unlawful processing of your personal data.

Pursuant to Article 13 of the KVKK, data subjects must submit their requests to our Company in writing or by other methods to be determined by the Personal Data Protection Board (the “Board”). In this context, applications to our Company may be submitted free of charge by completing this form, printing it, and delivering it to us through one of the following four methods.

2. APPLICATION METHODS

Method 1: Written Application in Person

Explanation: By the data subject applying to our Company in person. The data subject must have documents verifying their identity with them. The phrase “Personal Data Protection Information Request” must be written on the envelope.

Method 2: Application Through a Notary Public

Explanation: By notification through a notary public. The phrase “Personal Data Protection Information Request” must be written on the notification envelope.

Method 3: Application via Registered Electronic Mail (KEP)

Explanation: The application must be signed with a “secure electronic signature” as defined under the Electronic Signature Law No. 5070 and submitted accordingly. The subject of the e-mail must be “Information Request Under the Law on the Protection of Personal Data.”

Method 4: Application via the E-mail Address Registered in the System

Explanation: By using the e-mail address previously notified to our Company and registered in our Company’s system. The subject of the e-mail must be “**Information Request Under the Law on the Protection of Personal Data.**”

Third parties cannot exercise the right to obtain information regulated under Article 11 of the KVKK on behalf of data subjects. In order for the data subject to submit a request regarding personal data relating to a person other than themselves, the original wet-signed and notarized special power of attorney issued by the data subject in favor of the person who will submit the application must be presented.

Applications submitted to us will be responded to within thirty days from the date the request reaches our Company, depending on the nature of the request, pursuant to the relevant article of the KVKK. Our responses will be delivered to you in writing or electronically pursuant to Article 13 of the KVKK.
